HOMWORK POLICY 2025/26

Homework Policy

The school policy for homework was developed and agreed by the whole staff in consultation with parents and pupils and has the full agreement of the Governing Body.

1. Our Aims:

- Ensure that parents are clear about what their child is expected to do.
- Ensure consistency of approach throughout the school.
- To use homework as a tool to help to continue to raise standards of attainment.
- Improve the quality of the learning experience offered to pupils and to extend it beyond the classroom environment.
- Provide opportunities for parents, children and the school to work together in partnership in relation to children's learning.
- Encourage pupils and their parents to share and enjoy learning experiences.
- Reinforce work covered in class by providing further opportunities for the individual pupil.
- To practise or consolidate basic skills and knowledge, especially in Numeracy and Literacy.
- Encourage children to develop the responsibility, confidence and self-discipline needed to study independently.
- To prepare Year 6 pupils for the transfer to secondary school.

2. The Nature of Homework

It should be noted that homework can be set in many different forms with many different expectations and outcomes. It is important to remember that when setting homework there are a number of points to consider:-

1. The nature and type of homework changes throughout a pupils school career.
2. Amount and frequency of homework should increase as a pupil gets older.
3. Homework should not cause undue stress on the pupil, family or the teacher.

4. It will not necessarily come in the form of a written task.

3. Recommended Time Allocation

Homework should never be too onerous nor should it ever create stress within the pupil's family. If parents have any concerns they should not hesitate to contact the school.

The following are government recommendations as appropriate time allocations for homework activities:

Years 1 and 2 - 1 hour per week

Years 3 and 4 - 1.5 hours per week

Years 5 and 6 - 30 minutes per day

4. Homework Tasks (examples)

Years 1 and 2 - spellings, reading tasks, Ed City, RWInc sounds

Years 3, 4, and 5 - Learning Logs

Year 6 - regular homework focusing on new concepts and common misconceptions

The cross curricular homework will be in the form of an open ended question set by me 'Headteacher's Question of the Week'. The question can be interpreted in any way. It is designed so the children can think creatively and produce any form of response. It could be a model, a project, a diagram, a chart -whatever idea they think best explores the question.

Many of the children told us they liked art / making type homework, so this should give them a chance to create and produce some original work. This homework is optional and will not be formally marked; however, responses will be displayed and discussed during whole school assemblies and certificates given.

5. Role of the Pupil

All children are responsible for completing homework tasks on time. If a child does not complete his homework on time, the teacher will indicate additional time for completion (playtime and / or lunchtime). As homework is part of teaching and learning and a very important aspect of Behaviour for Learning the child will be issued with two reminders if homework is not submitted on time.

6. Role of the Class Teacher

- To provide an explanation of homework tasks to parents when necessary and give guidance of how they might assist their child. This may be done

by a note with the work or in the diary, at a parents' meeting or at an open evening.

- To set up regular homework in an easily followed routine.
- To ensure that homework is set consistently across classes.
- To set homework that takes equal opportunities into account.
- To ensure any homework is purposeful and links directly to the taught curriculum.
- To reward and praise children who regularly complete homework tasks.
- To mark homework and give feedback to pupils.

7. Role of the Headteacher and Governing Body

- To check compliance of the Policy.
- To meet and talk with parents when appropriate.
- To discuss with staff how far the policy is being successfully implemented.
- Inform new parents to the school so that they are aware of the home/school agreement and what it entails.

8. Role of Parents/Carers

- To sign a home school agreement dealing with homework.
- To support the school by ensuring that their child attempts the homework.
- To provide a suitable place for their child to carry out their homework.
- To encourage and praise their child when they have completed their homework.
- To become actively involved and support their child with homework activities.
- To make it clear that they value homework and they support the school by explaining how it can help learning.

At Handford Hall Primary School we provide weekly Homework club during lunchtime.
